STATEMENT OF FAITH

The strength of First Christian School is founded on the basis of unwavering faith in the following:

ADMISSIONS POLICIES

It has and shall be the policy of First Christian School the admission of students not to discriminate on the basis of the applicant's race, color, sex, national or ethnic origin. We reserve the right to select students on the basis of academic performance, religious commitment, and personal qualifications, including a willingness to cooperate with the staff and administration of First Christian School.

Students seeking admission will be evaluated on the basis of their transcripts, admission questionnaire, interview, and the ability to perform satisfactorily at First Christian School. Students with less than a "C" average in their academic subjects may have difficulty attaining a satisfactory level of academic achievement. FCS strives to meet all children's educational needs. However, we are limited in outside support for children with special needs.

The student must have a sincere desire to attend First Christian School and be willing to submit to all the standards and regulations of the school. The student must be respectful to his/her peers, staff, and faculty.

Attendance at First Christian School is a privilege, not a right. No student will be admitted directly following suspension or expulsion from another school. Students will strive to do their best in all areas. First Christian School is not a refuge for students who will not cooperate, have had previous behavioral problems in other schools, or who will not apply themselves to the best of their academic abilities. All new students will be subject to a 1 month probationary period for academic evaluation.

PARENT PLEDGE OF SUPPORT

1. We will support the principles and goals of the school by building Godly character through our training and example in the home.
2. We will support the discipline policy of the school.
3. We will send written notices for student absences or tardiness. We will do our best to get our children to school on time and to pick them up promptly after school.
4. We will assume responsibility for working with our children on the completion of homework or other school work as requested by the teacher.
5. We will read all school communications and respond as needed.
6. We will sincerely attempt to attend all regularly scheduled parent functions.
7. We will pay our financial obligations to the school promptly. We also agree to pay for any damages caused by our children.
8. We will clarify and work out any problems or misunderstandings we have with the school according to scriptural principles. (e.g. Matthew 18:15-17)
9. We authorize FCS to photograph or agents of FCS to photograph our child, and agree that they may use the prints to promote and support FCS. All negatives and proofs of aforementioned pictures will be the expressed property of FCS.

***Tuition is annual and not monthly, and is billed over the 9 month school year. The above rate would be divided by 9 to figure the monthly billing rate. Billing is from September through May. Tuition, Before and After School Care are billed on a full-month basis. No prorations of months will be billed.**

***Students who transfer out during the year must complete an enrollment change form at the school office by the 10th of the month to be effective on the 1st of the next month. In instances of withdrawal, pre-paid tuition will be refunded, based on the actual amount of time in attendance.**

*Payments are due by the 1st of each month. A late fee of \$50 will be assessed if paid after the 10th. Our entire budget comes from tuitions paid, as we have no other source of income. Any check returned to the school by the bank will result in a \$25.00 charge to the account. At the time of billing, any account that has a balance from the previous month is considered in arrears. You will be asked to withdraw your child from the school until your account is paid in full. Your child's spot cannot be guaranteed to stay open. We will call from the waiting list.

Before & After School Care:

The Before & After School Care programs of First Christian School are provided for First Christian School students only. There will be a \$2.00 late fee for each minute that a child is not picked up after 5:30 PM (Max. \$50 per day). To be in the Before or After School Care programs, each student must have completed the proper enrollment procedures. **It is not a drop-in center and the fee is a flat rate.** No credit is given for absences, vacations, or holidays.

Medical Treatment Consent:

First Christian School does not supply any type of medication because of state laws governing the dispensation of medication. All medications must be supplied by the parent/guardian in the original container, whether prescription or over-the-counter. All medications must be accompanied by a written consent form that you can pick up in the school office.

Release of Liability:
